

Health and Wellbeing Trail 2017 Prize Draw

Terms and Conditions

1. The prize draw (the "Prize Draw") is open to people aged over 18 or if you are under 18 and your parents have consented to your entry into the Competition and these Rules. Entrants must provide their email address or phone number after completing the health and wellbeing trail.
2. Employees or agencies of Lambeth Council, ("We") or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
3. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
4. By submitting your personal information you agree to receive emails from Lambeth Council containing information and developments that we think may interest you. You will be given the opportunity to unsubscribe on every email that we send.
5. To enter the Prize Draw you must complete the health and wellbeing trail getting 7 stamps on your 'health and wellbeing passport' and submit your name and email address or phone number. No purchase is necessary
6. Only one entry per person. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
7. Lambeth Council accepts no responsibility is taken for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by Lambeth Council
8. The closing date of the Prize Draw is 17:00 on Sunday 16 July 2017 Entries received outside this time period will not be considered.
9. Three prizes are available and winners will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random selection. The draw will take place on Wednesday 19 July 2017.
10. There are three prizes available:

1st prize - £75 in vouchers to spend at Morley's Department Store, Brixton

2nd prize - £50 in vouchers to spend at Morley's Department Store, Brixton

3rd prize - £25 in vouchers to spend at Morley's Department Store, Brixton
11. Lambeth Council accepts no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from the department store).

12. The winner will be notified by email or telephone on or before 28 July 2017. If a winner does not respond to Lambeth Council within 14 days of being notified by Lambeth Council then the winner's prize will be forfeited and Lambeth Council shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and Lambeth Council shall be entitled to select another winner.

13. The prize will be sent to the winner by Lambeth Council by post.

20. Lambeth Council reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Draw with or without prior notice due to reasons outside its control (including, without limitation, in the case of anticipated,

suspected or actual fraud). The decision of Lambeth Council in all matters under its control is final and binding and no correspondence will be entered into.

21. Lambeth Council shall not be liable for any failure to comply with its obligations where the failure is caused by something outside its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any other circumstances amounting to force majeure.

22. The Prize Draw will be governed by English law and entrants to the Prize Draw submit to the exclusive jurisdiction of the English courts.
